Strategic Plan

A **strategic plan** is a plan that talks about what we want to see happen and why.

It then looks at how we can help to make these things happen. These are our **goals**.



Inclusion Ireland's Strategic Plan 2023-2026 shaped everything we did this year. Our strategic plan has three key strategic goals.



Goal 1: Campaigning.

We campaign for real change in people's lives



Goal 2: Self Advocacy and Participation.

We support people with intellectual disabilities to be valued and to participate in society.



Goal 3: Accessible Communication.

We are leaders in accessible information and communication.





Our Work On: Campaigning

Campaigning is a core part of Inclusion Ireland's work. We promote change in society so that people with an intellectual disability are treated as equal and valued citizens.



In 2023, in close partnership with our self-advocates, we designed and implemented campaigns around the Government Budget, as well as in housing, employment, the Cost of Disability, the Wage Subsidy Scheme, and education.



Budget Submission 2024

In putting together our Budget Submission for 2024, we consulted with people with an intellectual disability and their families.

Money and the Cost of Disability were the main concerns for people who completed the survey.



Housing

In 2023, Inclusion Ireland continued its close engagement with the Housing Agency and the Department of Housing on the implementation of the National Housing Strategy for People with Disabilities (NHSPD).



The Implementation Plan for the Strategy was released in June 2023 and we are a member of the group that oversees how the plan is working.



Inclusion Ireland regularly meets with our Housing Working Group which includes members who have an intellectual disability.



We sit on several Housing Disability
Steering groups and are working on helping
them to be accessible so that selfadvocates can sit on them too.



We continued to work on supporting decongregation with Aurora: Enriching Lives, Enriching Communities.


Employment



We led a project to help support more people with an intellectual disability to enter the workforce. This was funded by the Irish Human Rights and Equality Commission.



A working group that had 6 members with an intellectual disability did training on employment law.



Their valuable work then included:

3 events to teach people with an intellectual disability about employment and learn about their experiences.

The launch of the Employment Code of Practice.



They released their exciting podcast called **Make it Work!**



There were 3 epoisodes of the podcast.

These looked at the path to employment for people with an intellectual disability.

Inclusion Ireland advocated for changes to the Wage Subsidy Scheme. The minimum weekly hours required for eligibility were lowered from 21 to 15.



In the past, the scheme left out many people with an intellectual disability, who often work on a part-time basis.



Cost of Disability

The Government created a document that asked people to talk about certain changes to how disability support payments are made. This was called a Green Paper.



We took part in consultation events in Dublin, Cork and Athlone.



Advocates called for the Green Paper to be scrapped, and it was.



Education

Inclusion Ireland was delighted to have been invited to join the advisory committee for the review of the Education for Persons with Special Education Needs Act.



It is very important to make sure that the Act works well and is in line with children's rights as outlined in the United Nations Convention on the Rights of Persons with Disabilities and the United Nations Convention on the Rights of the Child.





In 2023, we released 'The Pathway to Inclusive Education'. This was a report which brought together the voices of young people with an intellectual disability, families, policymakers, and educators.





We also made an easy to read video about it that explored the journey to inclusive education and what it could look like.



Our Vision for Inclusive Education

We want to see children welcomed in their local school with the same equality of access as all other children.



Inclusive schools must have the things they need to meet all children's needs in the community.



They must be designed so that everyone can use and experience everything. This is called Inclusive Deisgn for Learning. There should be lots of areas to learn in different ways. Learning can happen anywhere.



The child's voice must be front and centre.



Staff in inclusive schools must be trained and have the expertise to support all children. Flexibility, creativity and rights-based supports are at the heart of inclusive education.



Review of Ireland by the UNCRC

Inclusion Ireland took part in a group calling for the review of Ireland by the UN Committee on the Rights of the Child (UNCRC).



Inclusion Ireland wrote a detailed report to the UNCRC. This is called a submission.

It talked about the challenges faced by children with intellectual disabilities in Ireland.



The submission highlighted the lack of advocacy services for disabled children, and the limited access to inclusive education. This included examples of:



• seclusion and restraint.



 poor access to the services that they need.





Our Work On: Self-Advocacy & Participation

People with an intellectual disability in Ireland are often left out of important conversations that affect their lives.



Goal 2 of the Strategic Plan 2023-2026 aims to support people with an intellectual disability to be valued and to effectively take part in society.



In 2023, self-advocates played a central role in the work Inclusion Ireland does.

They took part in discussions about living with an intellectual disability at various events and forums.

We also celebrated International Day of Persons with Disabilities with our selfadvocates taking centre stage.



Inclusion Ireland Self-Advocates, 2023

Kellie Byrne, Ellen Gavin and Jimmy Dooner were trained and supported to present on the Public Sector Duty at Citizens Information Offices across the country.



Margaret Turley presented at the Public and Patient Involvement in Health and Social Care Research in Ireland event about her work as a researcher.



Tamara Byrne continued her important work as an advocate with Inclusion Ireland and the European Disability Forum Youth Committee.

She addressed many groups about issues including job struggles, inequality and poverty.



Paul Alford has worked as a Self-Advocacy Project Worker at Inclusion Ireland for 19 years. He talks about his own journey and how he has learned how to use his voice.

He says, "It is very important for people with intellectual disability to have their voices heard".



Inclusion Ireland Self-Advocates, 2023

Lydia Fisher says that she did not know what she was missing out on until she joined Inclusion Ireland.



She was involved with our Employment Working Group and tells us about this experience. She says, "Through this experience, I learned a great deal about employment and how I can assist others in finding jobs".

Supporting Self-Advocates



We worked together with self-advocates and advocacy supporters to make a guide called Seak Up, Speak Out.



This training aims to support inclusive spaces where people with an intellectual disability can express themselves a feel valued.


Working with Other Organisations on Participation in 2023



The **Irish Banking Culture Board** held customer listening sesions with people with an intellectual disability.



This was to give a voice to people who often don't get to have their voices heard by the decision makers in banking.





At these groups, the IBCB learned how to meet everyone's needs in the best way for them.



The Oireachstas Disability Group is made of 6 (six) organisations which speak for disability service providers and advocacy organisations.



In 2023, the group met with TDs and Ministers to advocate on issues such as Housing, Cost of Disability, and disability services.

Working with Other Organisations on Participation in 2023



Inclusion Ireland and the Health Service Executive (HSE) held an event together about the Assisted Decision Making Act.

We also worked with the HSE on:

 a survey that asked about Residential and Day Services.




 a guide for HSE and HSE-funded services with ILMI. This guide told people about how important it is to involve and listen to people with an intellectual disability.

Supporting Families

Inclusion Ireland continued to support family members and friends of people with intellectual disabilities through our **Connect Family Network (CFN)**.



We held information sessions including:

- Assisted Decision Making (Capacity) Act 2015 and Decision Supportive Service (DSS) with Áine Flynn, Director of the DSS.
- Organising a Family Support Group.
- Education: Advocating for Your Child
- Alternative and Augmentative Communication (AAC).



Members of the CFN added to Inclusion Ireland's advocacy work through focus groups, meetings and surveys. Their input helped to shape how we do our work and let us know what people needed.



We also worked with the Laois Offaly Children and Young People's Services Committee.

Together we made a guide about how best to support children and young people with disabilities. It included a directory of supports and services.



International Day of Disabilities

Inclusion Ireland joined up with Trinity Centre for People with Intellectual Disabilities to work on an event for International Day of Persons with Disabilities.



People with an intellectual disability came from across Ireland on December 4th to talk about about living and getting around in their communities.



They talked about problems including how it can be hard to get to places in their local area.



The event showed how County or City Councils can work with transport services to make communities more welcoming to everyone.

It was led by people with an intellectual disability and kept their experience and voice at the heart of the event.



Our Work on: Accessible Communications



Access to information helps people to know their rights and to have a voice. It supports respect and community inclusion. This is why it is an important part of our Strategic Plan.



We want a future where accessible information is the norm, especially for people with higher support needs.



We are working hard on our accessible communications department along with easy-to-read experts. We have been supporting accessible communication across the country in 2023.

Accessible Communications Efforts in 2023



Our easy-to-read experts are people with an intellectual disability who use easy-to-read themselves. We have been working together on lots of projects to make information more accessible.



These include work with the HSE, the European Disability Forum, The Housing Agency and disability service providers across Ireland.



All of our Inclusion Ireland documents have been co-produced with our easy-to-read experts. These include our:



- Pre-Budget Submission
- Annual Report
- Annual General Meeting
- Inclusive education report, The Pathway to Inclusive Education.





We joined with partner groups in Europe to work on easy-to-read research. This was to learn the best ways of teaching people about easy-to-read and how to make it well.



We tested a new training workshop. This will teach people how to make sure all of their work is accessible and inclusive.
